#### What We Can Do

- Create flexible learning programs that allow mastery through performance instead of seat time – which is allowed in Kentucky (704 KAR 003:305)
  - The pupil is participating in standards-based, performance-based credit that is awarded in accordance with 704 KAR 003:305, and that falls within one (1) or more of the categories of standards-based course work. A pupil may be counted in attendance for performance-based credit for a class or block for the year or semester in which the pupil initially enrolled in the class or block if the pupil demonstrates proficiency in accordance with local policies.
- Make learning programs relevant to students' needs, goals, and aspirations
- Address student and parent concerns about social, academic, family and religious issues in schools
- Meet regularly with homeschool students and parents
- Design programs and services that target homeschool students

#### **Action Plan**

- Host a Meet and Greet Establish a venue to inform and showcase successful education and personalized learning opportunities offered from Fleming County Schools. Invite all home school students to attend via mail or phone call; merge parents and students into informational settings, college and career readiness choices, virtual learning and pathways.
- Compile a list of barriers through parent interviews. Discuss and address barriers at Senior Leadership Team.
- Conduct e-mail, phone and home visit outreach to Fleming County students who are in home school but not currently enrolled in Fleming County Schools.
- Advertise! Place in the newspaper and on social media.
- The recruitment team will conduct "quarterly review meetings" and produce year end reports detailing progress and data on students.
